Devon Air Ambulance Trust (DAAT): a public meeting, led by Toby Russell of DAAT, will take place on Wednesday 5^{th} September, 6.30 - 7.30pm, at the WI Hut and all are welcome to attend. Discussion will take place around whether a helicopter night landing site, at the Recreation Ground, is a good idea and, if so, what process needs to be followed to achieve such a project. There will be information at hand and an opportunity to ask questions but if you can't make the evening you can e-mail any comments to me at thorvertonpc@gmail.com

New Cemetery: permission to go ahead with the required further archaeology dig at the site off Dark Lane is now being sought from the Church Commissioners being the current land owners. It is hoped that the 'community based dig' will take place next spring and if you are interested in being part of this project please let me know if you have not already done so already.

Dark Lane wall: quotes are now being sought for the required repairs to the wall and grant funding is being investigated. Further consideration will be given to the way forward on this matter at the September meeting.

Planning:

- **a) 18/00977/HOUSE** erection of a barn for ancillary domestic use and storage of tractor and garden machinery at Orchard House, Thorverton. The PC made no comment on this application.
- **b) 18/00986/CAT** notification of intention to fell 1 Spruce tree within a Conservation Area at Black Rod, 1 Jericho Street, Thorverton. The PC made no comment on this application.
- c) 17/001716/FULL widening of the existing access to agricultural land at School Lane, Thorverton. It was resolved that a representative from the PC would attend the MDDC Planning Committee Meeting in which the decision on this application would be confirmed.
- d) 18/00656/HOUSE erection of two storey side extension and single storey extension to front and rear at 4 Cleaves Close, Thorverton. Permission granted.
- e) 18/00245/FULL retention of shed and decking opposite Dinneford Spring, Thorverton. Permission granted.

General Data Protection Regulations: following the announcement of new rules and regulations in May this year the PC has adopted Privacy Statements, in line with recommendations, together with a new GDPR Policy, a copy of which can be found on the website, and is working towards full compliance with requirements.

Health and Safety Policy: a new Health and Safety policy has been adopted - a copy can be found on the website.

Permanent Post Office site: the PC resolved that it is not currently in a position to support a permanent post office building and/or site but that it would be in a position to provide support with replacement temporary accommodation when this becomes necessary.

Village Tidy Up Day July 7th 2018: the PC was disappointed that only 12 residents attended this event, after such terrific support last year, but this did not stop a great deal of work from being completed throughout the morning and the PC would like to thank all those who helped. The Jubilee Green, Recreation Ground and Leigh Gardens are now tidy, there are two refurbished wooden benches in place on the Jubilee Green and the stream has been cleared.
