The nationally agreed increase for 2023-24 was implemented in March 2024 and thus was carried forward to 2024-25 because of the lack of cheques. The increase was +7.57% at the clerk's SCP (14) which cost an additional £468 in monthly cist and 390 in backpay. The 2024-25 nationally agreed pay increase was +4.43% which was paid in March 2025 adding an additional £271. These three amounts reduce the difference to £14 which is +0.24%
