As you are aware 106 funds currently allocated to this community are Public monies, destined to benefit the whole parish community,

In the October and November 2019 minutes it appears to suggest that a particular S106 application had not gained (TPC) support due to the fact that it was "not consistent with suggestions gained from the public in 2018 regarding the spending of S106 funds". It appears that TPC may have been unaware that the funds

were held in fact in the gift of the district and that it has now made the TMGT aware of this fact. Hence the request for clarification please.

1. Please confirm if the council is still using the public list they gained earlier in the year to guide them regarding the spending of 106 funds as mentioned in the November 2019 minutes

how this policy may have changed and what may have replaced it?

3. Please confirm if your councils now has an alternative policy for gathering eligible, properly researched and costed proposals ready for presentation to the community in order for them to make a decision on how they wish to spend their money.? 4. If the answer to question 3 is no, please advise when you intend to publish a new policy detailing a

timetable that demonstrates how the council intends to go out to the community in order to request bids, check the proposals received for eligibility, then bring them in front of the community for final

5. Finally, also if the answer to question 3 is no, do you believe that it is TPCs role to publicise the actual rules and inform them of the change? If not can you confirm that the public may then submit their own bids for 106 funds direct to the 106 officer at MDDC?

Is it possible to please attach to your reply the original list of public suggestions given to the council to which you have referred.
